**Signal Word:** Danger

**Hazard Statement:** Causes eye, skin and mucous membrane burns.

#### Acute Effects

### 04 First Aid Measures

**Eye Contact:** Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.

**Skin Contact:** In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Get medical attention if irritation persists.

**Inhalation:** Move exposed person to fresh air. Flush mouth and nasal passages with water repeatedly. Get medical attention immediately.

**Ingestion:** Wash out mouth with water. Do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. If affected person is conscious, give plenty of water to drink. Get medical attention immediately.
